Artistic and production: Ballet West performed to sold out audiences at New York's Joyce Theater and Washington DC's Kennedy Center. At home, the Company broke records during every production, including the highest grossing Nutcracker run in the Company's 51 years. Finally, the Company had a successful campaign to eliminate all operational debt.

Academy: Ballet West Academy grew significantly in FY15 including two new locations: the Jessis Eccles Quinney Ballet Centre in Salt Lake City, as well as the Barbara Barrington Jones Family Foundation Ballet West Academy at Thanksgiving Point. Along with our studios in Trolley Square in downtown Salt Lake City, the school has an average enrollment of more than 360 students throughout the year. Another notable achievement was the hiring and onboarding of Peter Merz, a respected ballet instructor and administrator, as Academy Director. This year, the Ballet West Academy went from a regional school to a prestigious training ground known throughout the country as a world class facility with students from dozens of states, multiple countries, and instructors who are honored in their industry.

Education and outreach: Ballet West continues its commitment to providing quality education programs that allow teachers and students of all ages to experience the joy and magic of live ballet, regardless of financial or geographic barriers. The programs are supported by generous contributions from public-minded corporations, individuals, foundations, government agencies, and by a broad-based community support. This year, 18,739 students and teachers attended performances through in-theater student presentations and special needs Nutcracker performances at the Janet Quinney Lawson Capitol Theatre, giving these audiences an amazing touch point to the art form of ballet. Altogether, 101,755 students, teachers, and community members were reached through our Education and Outreach initiatives which visited 380 schools in 25 school districts.
